4. CLINICAL PARTICULARS

4.1 Therapeutic indications

UltraClear Plus is formulated to provide enhanced, specialized support for balanced metabolic detoxification, including macro- and micronutrients to address liver function.

4.2 Posology and method of administration

Shake canister before scooping. Blend, shake, or briskly stir about 2 level scoops of UltraClear Plus, into 240 ml of chilled water or juice twice daily or as directed by your healthcare practitioner. For highly sensitive individuals, consider reducing consumption to ½ to 1 scoop with 120 ml to 150 ml of chilled water or juice twice daily during the first 3 to 4 days before starting a full daily dose.

4.3 Contraindications

Do not use if you are pregnant or nursing.

4.4 Special warnings and precautions for use

If taking medication, consult your healthcare practitioner before use. Keep out of the reach of children.

4.5 Interaction with other medicines and other forms of interaction

None known.

4.6 Fertility, pregnancy and lactation

Excess vitamin A intake may increase the risk of birth defects. Pregnant women and women who may become pregnant should not exceed 3,000 mcg of preformed vitamin A (retinyl palmitate) per day unless directed to do so by a healthcare practitioner.
