INDICATION & PHARMACOLOGICAL ACTION

INTRINSI B12-FOLATE™ features the active forms of vitamin B12 and folate with intrinsic factor for enhanced absorption and utilisation. These nutrients help promote nervous system function and cardiovascular health.

Ingredients	Uses for ingredient
Intrinsic Factor	It is a protein secreted by the cells lining the stomach and it is essential for the absorption of vitamin B12 in the intestines. Our immune system operates as a finely orchestrated mechanism and cannot function effectively, without Intrinsic Factor. ¹
Folate (as Calcium L-5-methyltetrahydrofolate)	Folate is the natural form of vitamin B9 that the body needs to maintain its genetic building blocks, DNA and RNA. ² In addition, it supports healthy cell division. ³
Vitamin B12 (as Methylcobalamin)	Methylcobalamin is a naturally occurring form of vitamin B12. Vitamin B12 is important for the brain and nerves, and produce red blood cells. ⁴ Vitamin B12 is required for the development, myelination, and function of the central nervous system; healthy red blood cell formation ⁵ ; and DNA synthesis. AANDUIDING EN FARMAKOLOGIESE WERKING
