4. CLINICAL PARTICULARS

4.1 Therapeutic indications

Kaprex provides a safe option for effective joint relief. This proprietary combination of selected plant components influence kinase signalling and the formation of certain substances, such as PGE2, that are associated with minor pain. Clinical testing suggests that Kaprex may offer a high degree of predicted cardiovascular, gastric, renal, and liver safety.*
